Competition Terms and Conditions

1. By participating in Jack's Paint Head Office (promoter) Facebook and Instagram Competitions, participants agree to the terms and conditions set out below. The promoter reserves the right to disqualify a participant who does not comply with any of the terms and conditions of the competition.
2. The competition is open to everyone except for the following people:
 - a) a director, member, partner, employee, agent or consultant to the promoter or any other person who directly or indirectly is employed or associated to the promoter or the supplier of the goods or services in relation to the prize of the competition including the retailers of Jack's Paint; or
 - b) a spouse, life partner or any supplier staff directly associated with any person/supplier associated with the competition/promotion as contemplated in paragraph (a).
3. Participants must be a South African citizen or permanent resident with a valid South African photo identification document and must be over the age of 18 years to qualify for entry.
4. This competition is run on behalf of Jack's Paint Head Office by the advertising agency Word 4 Word Marketing Pty Ltd.
5. The Competition dates and deadlines for entry are specified in each individual promotion.
